R.P.A. (RED PENALTY AREA) (NO FREE RELIEF)

YPA. (YELLOW PENALTY AREA). (NO FREE RELIEF)

ALL Bridges are in the P.A. Play it as it lies or Relief is available. For a (1 stroke penalty) (swing & stance only) (two club lengths)

ALL Flower gardens are a NO PLAY ZONE ((short orange stakes)... Mandatory FREE relief at nearest point of entry (one club length)

ALL Worn access routes leading into bunkers are NOT part of that bunker. (NO FREE RELIEF)

ALL Unmaintained areas whether marked or unmarked are treated as a RED PENALTY AREA relief allowed for a 1 Stroke Penalty.

(two club length relief) the margin line of the area is the grass cut line where the grass is longer than ankle height. OR MARKED RED lines

HOLE #1 PAR 5......The semi maintained path that crosses the fairway at the bottom of the hill is a cart path. (FREE RELIEF) is allowed.

HOLE #2 PAR 4...... .RPA pond area at the right side of the green.

HOLE #3 PAR 3..... ...RPA creek crosses the fairway in front of the tee box, Worn dirt / gravel area left of the green IS part of the cart path. and is marked. (FREE RELIEF ALLOWED)

HOLE #4 PAR 3.......RPA creek behind the green, you may use the closest DROP ZONE for the relief, The far side of creek is OB.

HOLE #5 PAR 5......OUT OF BOUNDS ALL along the left side. The wire fence is an OB boundary fence. (NO FREE RELIEF)
The hedge left of the green is O.B.STAKED

The Bark mulch area behind the green is a flower garden MANDATORY FREE RELIEF.

HOLE #6 PAR 4.....OUT OF BOUNDS ALL along left side of fairway.

The metal drain culverts on the right side of fairway under the cart path is GUR.

The wooden toilet enclosure is an IMMOVABLE OBSTRUCTION......FREE RELIEF for Stance & Swing only.

 $\textbf{HOLE \#7 PAR 4}.........\text{The dirt worn maintenance path on the RIGHT side is NOT a cart path.} \ (\ \text{NO FREE RELIEF}\).$

OUT OF BOUNDS hedge behind the green.

Small flower garden right of the green MANDATORY FREE RELIEF.

HOLE #8 PAR 4.......The dirt worn maintenance path on the LEFT & RIGHT sides are NOT a cart paths. (NO FREE RELIEF).

RPA long grass area left side of the fairway near the green.

HOLE #9 PAR 5......The dirt worn maintenance path on the LEFT side is NOT a cart path. (NO FREE RELIEF).

OUT OF BOUNDS at the left side at the OVERFLOW PARKING AREA.

OUT OF BOUNDS behind the green . STAKED

The wooden fence at the Concession is an IMMOVABLE OBSTRUCTION (COMPLETE FREE RELIEF)

HOLE #10 PAR 4......OUT OF BOUNDS all along the RIGHT side of the fairway.

The practice area on the left is in the General Area and is in play.

HOLE #11 PAR 5.....OUT OF BOUNDS all along the right side.

The practice area on the left is in the General Area and is in play.

RPA behind the green and you may use the closest drop zone located on the left side & rear of the green.

HOLE #12 PAR 3......RPA creek all along the right side extends to infinity, and the bridge is in the RPA.

The wooden toilet enclosure is an IMMOVABLE OBSTRUCTION......FREE relief for Stance & Swing only.

HOLE #13 PAR 5.......Any tee shot from the Gold or Blue tees that does NOT clear the RPA. You may RE TEE or use the forward DROP ZONE tee box for your next shot. (Playing your third stroke)

IF you are UNSURE if it cleared the RPA then play a PROVISIONAL ball from that TEE or use the DROP ZONE

RPA all along the right side extends to infinity.

The burn pile waste area on the left side is an RPA.

There is an RPA short left of the green and the bridge is in the RPA.

 $The \ STONE \ MONUMENT \ at the \ bridge \ is \ an \ IMMOVABLE \ OBSTRUCTION \ FREE \ relief \ for \ Stance \ \& \ Swing \ only.$

RPA long grass area right side of the fairway near the green.

HOLE #14 PAR 5.......OUT OF BOUNDS all along the right side up to the RPA post at the right side of the green side bunker.

Please note the WHITE POLE & the RED POLE indicating the defined areas.

The circular garden area on the cart path is part of that cart path.

HOLE #15 PAR 4......Flower garden and screen left of the tee box is a NO PLAY ZONE. with MANDATORY FREE RELIEF point of entry.

OUT OF BOUNDS all along the RIGHT side of the fairway.

YPA crosses the fairway just in front of the green.

The small rock wall which is the 16th teebox is a flower garden, and if it interferes with your stance or swing then MANDATORY FREE RELIEF is available above on the 16th tee box.

HOLE #16 PAR 4.....OUT OF BOUNDS all along the right side of the fairway and behind the green.

HOLE #17 PAR 3.......The flower garden right of the green is a NO PLAY ZONE......MANDATORY FREE RELIEF at point of entry.

HOLE #18 PAR 4......OUT OF BOUNDS at the right side at the Wedding pavilion enclosure and the adjoing parking area. YPA crosses the fairway at the bottom of the hill.

ALWAYS REMEMBER IF YOU ARE NOT SURE ABOUT ANY RELIEF....PLAY 2 BALLS......

YOU MUST REPORT THIS AT SCORING.

IF YOU THINK THAT YOU MAY NOT FIND YOUR BALL. PLEASE PLAY A PROVISIONAL BALL. TO HELP WITH THE PACE OF PLAY
