EARLY PAYMENT REBATE (E.P.R.): Renewing members who pay by cash, cheque, debit, or online will receive a \$175. E.P.R. in the form of a Club Account Credit. Dues must be received in full prior to December 31st to receive the E.P.R. (no exceptions). Payments can be made in person during business hours at the golf club or through online banking. Monthly Full Play, Social and Junior Members do not qualify for the E.P.R.

Club Information & Policies



MEMBERSHIP DUES

- Annual dues run from January 1 to December 31 and are paid on a monthly basis or annually, payable via pre-authorized debit (PAD) or credit card (subject to a \$125 administrative fee).
- Dues are set following approval by the membership at the Annual General Meeting held each December and are due prior to January 31.
- Monthly payments are due on the 10th business day of each month and are processed through automatic bank withdrawal.
- Should a member choose to cancel a monthly membership before the end of the calendar year, a \$500 early exit fee will apply at the time of cancellation. Annual memberships are refundable upon board approval.
- It is expected that member dues may increase annually to account for rising operating costs, as determined by the Club's approved operating budget.

ENTRANCE FEE STRUCTURE

- An entrance fee is payable by any new member (excluding Juniors and Corporate memberships) joining Chilliwack Golf Club, as well as by any returning member who has previously resigned in the past or allowed their membership to lapse (some restrictions apply, please contact the office to learn more).
- The entrance fee may be paid in full or in equal monthly instalments.
- The spouse of an existing member is subject to the current entrance fee, less 50 percent, at the time of joining.
- Junior members who choose to continue their membership are required to pay the entrance fee upon reaching the age of nineteen.

CGC MEMBER CLASS "A" SHARE

- A Class "A" Share represents your voice in the ownership and governance of the Club. Each Member of Chilliwack Golf Club holds one Class "A" Share (per household) in Chilliwack Golf and Country Club Holdings Ltd., the company that owns the Club's land, buildings, and core assets. A Class "A" Share:
 - Provides one vote on important governance matters affecting the Club; confirms your role as a steward of the Club; is not an investment and does not pay dividends; cannot be sold or transferred outside of Club membership.
- Class A Shares are held only while you are a Member in good standing. If your membership ends, the share is repurchased by the Club for an amount set by the Board, with a minimum value of \$200, in accordance with the Club's Articles.

CLUB ACCOUNT

- Members may charge guest fees, food & beverage, lessons, and golf shop purchases to their account.
- Monthly club statements are available online.
- Statements are emailed by the 5th business day of each month, with balances due by the end of the following month. Pre-Authorized Debit (PAD) payments are processed on the 10th business day, with no charge for bank withdrawal and a \$125 annual administrative fee for credit card PADs. Outstanding balances may be subject to a 2.5% interest charge, and NSF fees are \$50 per occurrence.

Club Information & Policies

LEAGUE PLAY

- Tee times during league play are reserved for participants in those events. Members are encouraged to take part in their respective leagues, including Tuesday Ladies (8:30–10:30 a.m.), Tuesday Skins (11:30 a.m.–12:30 p.m.), Wednesday Men's Night (10:30 a.m.–5:00 p.m.), Thursday Senior Men's (8:30–10:30 a.m.), and Thursday Ladies Night (from 3:30 p.m. onward).

FOOD & BEVERAGE MINIMUM

- From March to November, Members must meet a quarterly minimum spend of \$180. Any shortfall will be charged at quarter-end. There is no minimum from December to February.

GOLF SHOP CREDIT BOOKS

- Over the course of the season, members may earn Golf Shop credits through various tournaments and league play. These credits are recorded in the member's Golf Shop account.
- Golf Shop "credit books" must be redeemed by December 31st of each year and do not carry over. Any unused credit will be forfeited upon termination of membership.

MEDICAL & LEAVE MEMBERS

- Members who have been granted board approval for Medical Leave or Leave of Absence will be charged a \$450 fee during the annual billing cycle.
- This fee will be applied as a credit toward the pro-rated rejoining costs when the member is ready to return.
- Please refer to the Medical Leave / Leave of Absence policy for additional details.

DRESS CODE

- Men must wear shirts with collars and sleeves, and ladies must wear shirts with a collar, sleeves, or both. Golf shoes or soft-soled shoes are required; metal spikes are not permitted. Blue jeans in acceptable condition are permitted from November 1 to March 31. Tee shirts, cut-offs, athletic shorts, and sweatpants are not permitted.
- Dress code does not apply to the driving range, however it does apply to the putting green and practice hole.

HOLE IN ONE INSURANCE

- Members who pay the annual \$30 Hole-in-One insurance premium are eligible for the Club's Hole-in-One Program, which is insured from January 1 to December 31 and billed on the November statement.
- Eligible members who record a hole-in-one will receive a \$300 Creekside Lounge credit, a commemorative Hole-in-One flag, and an invitation to the annual Hole-in-One Dinner.



Golf Services

Chilliwack Golf Club offers a range of optional golf services designed to enhance the overall member experience. These additional offerings provide members with greater flexibility, convenience, and opportunities to enjoy the Club throughout the golf season. Please note that the driving range closes every Monday at 2:00 p.m. from March through November to allow for clean pick and routine maintenance.
